

AUDITOR'S REPORT FOR THE YEAR ENDED ON 31ST MARCH, 2020

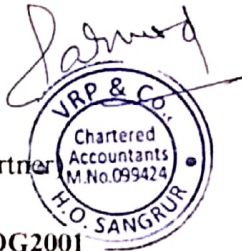
